This seminar is designed to provide a better and more comprehensive understanding of federal human trafficking crimes, which include both sex and labor trafficking. It will educate attendees on how to recognize common indicators that will identify potential victims, and it will provide methods for effective victim interviews and teach investigative strategies to enable them to successfully work cases of modern day slavery and sex trafficking in their communities.

Instructors include some of the nation's leading subject matter experts and topics include\*:

- Overview of human trafficking statutes and techniques to prove all elements based on most recent case law
- National and regional trends in sex and labor trafficking – do we have these in our region? Are we looking in the right place?

- Victim-centered, trauma informed approach – what is it and how do I do it?
- Proactive victim and case identification techniques using a multi-disciplinary team approach
- How to make your case larger and stronger
- Not another war story – sex and labor trafficking case studies with practical lessons learned
- Anticipating and defeating common defenses
- What’s my role – the roles of prosecutors and investigators on a human trafficking task force. Techniques to anticipate and face the growing pains
- Evidence to make a case stronger
- Navigating victim’s needs throughout the criminal justice system process – it takes a team
- What do I do with the victim who commits a crime?
- Restitution – investigator and prosecutor’s roles
